The 36. Internationaler ADAC Truck-Grand-Prix is the fourth round of the Goodyear F.I.A. European Truck Racing Championship (E.T.R.C.) 2023 and will be held at Nürburgring on 13-16 July 2023. The event consists not only of truck racing days, but also an industrial fair.
